IGM FINANCIAL INC. ANNOUNCES MARCH 2019 INVESTMENT FUND SALES AND TOTAL ASSETS UNDER MANAGEMENT

Winnipeg – April 3, 2019: IGM Financial Inc. (IGM) (TSX: IGM) today reported preliminary total investment fund net new money of \$2.3 million as shown in Table 1. Total assets under management were \$160.7 billion at March 31, 2019, compared with \$157.6 billion at February 28, 2019 and \$155.8 billion at March 31, 2018. Investment fund assets under management were \$154.3 billion at March 31, 2019, compared with \$151.6 billion at February 28, 2019 and \$149.2 billion at March 31, 2018. Assets under management are shown in Table 2.
